

## FALSE-FLAG TO WORLD WAR

A US, Israeli, or NATO military strike on Iran represents an irrevocable leap toward military and economic confrontation with Russia, China, and other members of the Shanghai Cooperation Organization (SCO). Such a world war will likely result in a mass global genocide or outright human extinction, and must be the paramount concern of any cognizant activist; all other causes, no matter their merit, should take a backseat.

In the past two weeks, top newspapers, intelligence officers, and politicians around the globe are warning of an imminent "sneak attack" strike on Iran. The deeper subtext is the collapsing global financial system of parasitic speculative debt, with Wall Street jackals like JPMorgan Chase, Goldman Sachs, and Citigroup dangerously exposed in the \$550 trillion derivatives bubble.

With the finance oligarchs in crisis and an American public cynically dissatisfied over the bloodshed in Iraq, the nexus of criminals centered around Vice President Dick Cheney may desperately orchestrate a catastrophic WMD false-flag for "political capital," to be blamed on Al Qaeda, Hezbollah, or "homegrown terrorist" patsies, followed by the immediate destruction of Iran via STRATCOM's nuclear "Global Strike" plan.

Regardless of if and when the strike on Iran occurs, it represents a real and existential threat which must be confronted immediately. And while the use of nuclear weapons against Iran should be actively opposed, activists must also recognize the emerging apocalyptic threat from "next-generation" weapons systems: directed energy and space-based lasers; neutrino and anti-matter devices; weaponization of "cold fusion" & other "zero-point" free energy technologies; genetically engineered bio-warfare; artificial intelligence & "synthetic reality" environments; self-replicating nanotechnology & cloning; Tesla scalar weather modification; and other "singularity" technologies designed for the "transhumanist" merger of humans and computers.

If the foundation-funded "anti-war" Leftist groups and appointed "progressive leaders" continue to censor the discussion on these vital issues, while omitting any references to 9-11 and the history of false flag terrorism, they become morally complicit in current and future war crimes. Those who seek to discredit the Kennebunkport Warning exhibit a devastatingly tragic myopia (or worse), as they selfishly attempt to engineer a divisive conflict entirely of their own creation, while foolishly ignoring the material substance of the document. The continued bipolarity of a few tepid "anti-war" activists

concerning the issue of false-flag terrorism should not distract from the imperative goal of preventing a world war starting in Iran.

Fully conscious activists should call for the impeachment & conviction of Vice President Dick Cheney and his Chief of Staff David Addington, with the clear recognition that they are tumorous symptoms of a systemic cancer, spanning from the Anglo-Dutch oil cartel to the "shadow government" tentacles of the national security state.

This grouping includes, but is not limited to: the Israel-first neocons in the National Security Council & Pentagon cabals like the Iran-Syria Operation Group; the Continuity of Government generals inside NORTHCOM; the Strangelove madmen at STRATCOM and US Space Command; the surveillance nexus inside the National Reconnaissance Office (NRO), National Security Administration (NSA) & National Geospatial-Intelligence Agency (NGA); "private" military contractors like SAIC, Raytheon, Boeing, Lockheed, BoozAllenHamilton, Northrop Grumman, L-3 Communications, Blackwater, and Dyncorp (who often work in tandem as a near-parallel government via programs like "Future Combat Systems"); and the army of mercenary scientists crafting new weapons of mass murder at research labs like Los Alamos, Lawrence Livermore, Sandia, and NASA Ames Research Facility.

Additionally, the world's central banks should consider a new Bretton Woods agreement between G8 nations to stabilize the collapsing US dollar and economic house of cards, in order to halt an expansion of the growing global Great Depression. Congress should institute the taxation, regulation, or outright elimination of hedge funds, derivatives, and similar debt-based ponzi schemes managed by the vulturine private banks.

Realistically however, the politically astute should focus their energies on preventing new false-flags and strikes on Iran, without expecting help from compromised pro-war Democrats in Congress, fringe Republican presidential candidates, or the militarized corporate media. Additionally, activists should properly plan contingencies for personal survival and mass resistance in the event of domestic martial law or an expanded war.

Those with a serious interest in preserving the human race must overcome their crippling cognitive dissonance and instead resolutely confront the perilous political reality outlined in the Kennebunkport Warning.
